MINUTES OF FEBRUARY 25, 2014-

OLD BUSINESS-

1. Town Board Liaison:

Mr. Burdick reported that he has conversed with Supervisor Norton regarding the Committee's request for the Town Board to clarify the role of Town Board Liaison. Mr. Burdick agreed to inquire if the issue will be on the agenda at the Town Board's next meeting.

2. Website:

Mr. Burdick explained that he would like to make clean, unmarked copies of the comment packets available on the Committee website. He has asked the Town Clerk if she has an additional unmarked copy, but she does not. None of the Committee members present had a complete unmarked set. Mr. Burdick will continue to look for a copy.

Committee resumed classification of comments into master plan categories, with comments numbered 72-79 classified.

NEW BUSINESS-

1. Consultant:

Mr. Angell commented that if the Committee will be hiring a consultant, it may be helpful to involve them in the review process when the Committee begins to review the substance of the comments. Mr. Layton commented that the Committee needs clarification on whether they have been charged with drafting proposed changes to the Draft Master Plan. He noted that he feels it is premature to involve a consultant in the process at the present time.

Mr. Angell noted that review of the substance of the comments is technical. He and Mr. Lovett also noted that the process of hiring a consultant was time consuming for the Master Plan Committee, and that the DMPC may want to consider starting the process now. Discussion continued. The Committee agreed to continue this discussion at their next meeting.
